## **CONTEST RULES**

- 1. Eligibility.
- (a) No purchase necessary to enter or win.
- (b) The 1 Second, 1 Song Sweepstakes is open to U.S. residents, 18 years of age or older, except employees of all El Dorado Broadcasters, LLC stations and Lawman Promotions, LLC. (collectively, the "Sponsors"), Other television and radio stations in all El Dorado Broadcasters, LLC. Market Areas, and their affiliates, subsidiaries, advertising or promotion agencies (if any), members of their respective families or persons living in the same household. This Promotion is subject to all applicable federal, state, and local laws and regulations. Void outside the United States and where prohibited.
- (c) Listeners are eligible to win an El Dorado Broadcasters, LLC contest only once every thirty (30) days. Only one winner per household is permitted in any contest. Listeners are eligible to win a prize valued at \$600.00 or more only once every six months.
- (d) Participants must sign all contest release and waiver forms before accepting prize.
- 2. Entry.
- (a) The Contest will begin on Thursday 9/10/2020 and end on Friday 10/30/2020 The deadline for entries is Wednesday 10/30/2020 at 10p PST.
- (b) To participate in the Contest, listen to KZXY FM weekday mornings at 6, 7 and 8:40. KZXY FM will solicit for caller number 20. That caller will then go on the air with KZXY FM and we will play one second of a song for the listener. All songs for the contest are either playing or have played on KZXY FM. KZXY will play one (1) second of a song, ask the listener if they know what the song is. The listener may ask us to play the snippet a second time. If they guess the correct song, they win \$100. If they cannot guess we move on to the next hour with a new listener. If after 8:00 we do not have a winner for the \$100, the \$100 will rollover to the next day. Once we have a winner for that day the contest suspends until the next weekday. The prize amount will increase until someone gets correctly guesses The One Second Song. We will use a different song each day.

There is no alternative method of entry for this contest. If participants attempt play the contest outside of the contesting windows, they will not receive any confirmation of qualification or confirmation of receipt of entry.

(d) Sponsors are not responsible for technical, cell phone or computer failures, errors or data loss of any kind, lost or unavailable Internet connections, failed, incomplete, garbled or deleted computer or network transmissions, inability to access any website or online service, any other error or malfunction, late, lost, illegible or misdirected entries, or for printing errors in any advertisement, entry form or the rules. Sponsors reserve the right to disqualify any entrant that tampers with the operation of the Contest or violates the Official Rules of the Contest.

## 3. Prizes and Odds of Winning.

(a)DAILY PRIZE 1 time per day: One (1) One Hundred Dollar (\$100) will be awarded throughout the duration of the contest. Prizes will be awarded as participants guess the correct song. The prize amount will vary depending on the number of daily winners and will be a minimum of \$100 per day. Prize amount will rollover at the end of each contest day by \$100 if there are no correct guesses during the execution of the daily contest. The Sponsors reserve the right to award any prizes that are not claimed by November 30th<sup>th</sup>, 2020 in future promotions conducted by the Sponsors.

- (b) Odds of winning depend on number of participants
- (c) All winner information will be collected at the time of winning. The information will be sent to the Lawman Promotions, LLC to issue a check to the winner. This process will take 6-8 weeks before winner will be notified to pick up check. Any prize or prize certificate not claimed within 60 days of winning will be forfeited by the winner. In the event that a prize or prize certificate is mailed to the winner, it will be with the prior written consent of the winner and, therefore, winner assumes the risk of its arrival.
