(effective Monday, May 8th, 2023 12am)

NO PURCHASE NECESSARY. VOID WHERE PROHIBITED.

- 1. CONTEST PERIOD:** Contest begins at 12AM on Monday May 8, 2023 and ends on Thursday, June 0th, 2023. (“Contest Period”), excluding weekends during the Contest Period Monday May 1, 2023 and ends on Saturday June 29th, 2023
- 2. HOW TO ENTER:** During the Contest Period, go to Y102fm.com and submit your recipe and/or dinner suggestion. One suggestion/recipe per household per day. A “day” is defined as a twenty-four (24) hour time period beginning at 12:00:01 a.m. (midnight) PST and ending at 11:59:59 p.m. PST. The time clock of the Contest Administrator is the official clock for this Contest.
- 3. ELIGIBILITY:** The Contest is open only to individuals who are legal residents of the United States residing in California in the Stations DMA who are 18 years of age or older at the time of entry. Employees, contractors, directors, and officers of El Dorado Broadcasters LLC or EDB VV License LLC or associated companies, Company (“Sponsor”), and the immediate family members (spouse, parent, child, sibling, grandparent, and/or “step” of each) and those living in the same households as such employees are ineligible.
